




Ordinance Number:

Be it ordained/resolved by the **Mill Creek Community School Corporation** that for the expenses of **MILL CREEK COMMUNITY SCHOOL CORPORATION** for the year ending December 31, **2017** the sums herein specified are hereby appropriated and ordered set apart out of the several funds herein named and for the purposes herein specified, subject to the laws governing the same.
